The Town Council of Bogue met Monday, February 17, 2025, at the Bogue Town Hall, 121 Chimney Branch Road.

Clerk Southard presented a resolution to repeal State Law 2024-57 where the State Legislation changed local government rules that would make downzoning only allowable if affected property owners approved.

Councilman Dale made a motion to accept the Resolution in Support of House Bill 24, An Act to Restore the Authority for Local Governments to Initiate Downzoning. Councilman Taylor seconded. Motion passed unanimously.

Mayor O'Chat stated that last year resident Juli Cosgrove recommended having new Town street signs and directional signs so that they all matched and would make the Town look better. Mayor O'Chat asked if the Town Council agreed as we would need to budget for it in the new fiscal year. Clerk Southard stated that there are funds in the Capital Outlay for this fiscal year as well. The Town Council discussed replacing signs to keep it consistent and asked Clerk Southard to look into the cost.
